



# SANFL CONDITIONS OF ENTRY

---

- Prohibited items:
  - Alcohol, glass bottles or cans
  - Professional standard still or video cameras and audio recording devices
  - Flares, fireworks and laser pointers
  - Confetti, shredded items or cash register rolls
  - Whistles, air horns and vuvuzelas
  - Weapons, guns and knives (or any object that could be used as a weapon)
  - Animals (except guide dogs and other bona fide assistance animals)
  - Any other item considered by SANFL's representative deemed to be dangerous
- Ground management or a SANFL Official reserves the right to search bags for prohibited items and confiscate such items in its absolute discretion. This may include visually or physically inspecting the bag and/or seeking your assistance to remove items from the bag. Ground management and SANFL also reserves the rights to conduct 'pat down', 'wandering' or other reasonable personal checks of patrons as they enter or exit the venue.
- Ground Management or a SANFL Official reserves the right to refuse entry to any person.
- Patrons who cause a disturbance, are offensive, discriminatory, display anti-social behaviour, use foul or abusive language, make racial or threatening remarks or gestures or refuse to comply with reasonable requests by Ground Management may be evicted and may be banned from future attendance.
- Patrons are not to interfere with, obstruct or hinder SANFL or its employees, agents or contractors in the exercise of their powers, functions or duties.
- The use of photographic, video or audio equipment for commercial purposes is **not** permitted.
- Patrons are not permitted to transmit, broadcast, sell, license or otherwise publish, or reproduce any recordings (including photographic, video and sound recordings) of the match without the prior written approval of SANFL. Such recordings may be confiscated or erased.
- Patrons may be filmed, recorded or photographed by official broadcasters or photographers and these images or recordings may be used without consent of, or payment or provision of other compensation to, patrons for all manner of official broadcast and promotional purposes.
- Patrons acknowledge that SANFL and third parties authorised by SANFL may make, create, store, record, transmit, reproduce or use recordings and images or any likenesses at or in relation to the event (including, without limitation, of Patrons).
- Patrons grant SANFL and third parties authorised by it, permission to use any recordings, images or likenesses of the Patron in any media world-wide and for any purpose without identification, compensation or payment of any kind.

- It is a condition of entry that the SANFL, Club and its servants and agents shall not be liable to you for any loss or damage, (including without limitation, loss or damage caused by the negligence of the SANFL, Club or its servants and agents and incidental and consequential loss or damage), arising in any manner wholly or partly from or in connection with your use of these grounds.
- If you contravene any of these conditions of entry you may:
  - be required by a SANFL Official or Ground Manager to provide your name, address, photograph and other relevant personal information (Personal Information); and that
  - if you are required to provide your personal information, SANFL will at all times deal with your Personal Information in accordance with the Privacy Act 1988 (Cwlth) and SANFL's Privacy Policy which can be accessed on SANFL's website. You consent to SANFL, the Venue and any relevant third-party service providers using your personal information in connection with investigating, documenting and analysing any possible breach of these conditions of entry or the law.
- SANFL promotes the responsible service and consumption of alcohol.
- No ticket refunds will be paid.
- No representations are made that there is space available in the ground suitable for viewing the match.
- Concession patrons are required to present a valid concession card at time of entry.

#### **As You Leave the Ground...**

Please respect our neighbours when you are leaving by keeping noise to a minimum.

Under the Liquor Licensing Guidelines, alcohol must not be removed from the ground.
