

## **Win one of three VAILO ADL500 SANFL competition packages – Terms and Conditions**

1. Information on how to enter and prize details form a part of the competition terms and conditions of entry (**Terms and Conditions**).

4. All employees and their immediate families of the Promoter and its related bodies corporate are ineligible to enter.
