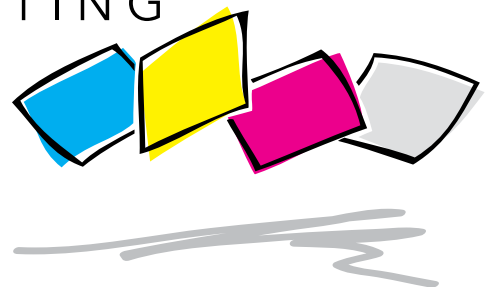

PRESIDENT'S ANNUAL REPORT

We all have the same goals: to win games of football, to make a profit and to have our club respected and consistently successful. Over our history, we've achieved all of those things at times, but have often quickly slipped back to something less than what we should be. Your Board is determined to bring consistency to our club, both on and off the field. We have to change in some respects and we have to be prepared to fight to survive and flourish in an environment that is constantly becoming more difficult. That is not harsh, it's the reality we face if we're to succeed.

On field, 2017 saw us unable to win a game in the first half of the season, but then turn things around with 5 wins from our last 8 games. That was a pleasing progression, but the reality is that the season had gone by then. However, a strong platform has been built around a host of talented, young players and our task is now to nurture that talent and improve it. Future premierships won't come from scattered interstate recruiting, but it will come from the talent within, supplemented by the right recruits to boost what we have.

Season 2017 saw the last year of Mark Mickan's 4 years as our coach. Rather than reiterating Mark's numerous qualities that we all know so well, I'd rather just list some key moments:

- Of course, our 2015 Premiership, including a Grand Final won by the players, but to those close to the group, also won by great coaching before and during the game.
- The huge crowd back at the club after Mark's last (winning) game and the love and respect for a man of character and his family.
- Winning 4 Best and Fairest awards, including 1983, where he was adjudged the best player in possibly the best West Adelaide team ever.
- The manner in which Mark accepted the club's decision to appoint a new coach.

There is so much else, but the thanks and respect from everyone at Westies is testament to a legend of our club.

The foundation that Mark has laid will be developed and grown by our new coach, Gavin Colville. Not only has Gavin impressed us all over the past 2 years as Development Team coach, his presentation for the coaching job, amongst a quality field, was outstanding and the enthusiasm that has followed his appointment is strong and continuing. On the field, we must constantly demand higher standards, disciplines and selflessness and we're confident Gavin will achieve that.

Our ability to recruit has been severely compromised this year by salary cap restrictions, as one of a number of conditions of SANFL funding grants. We are grateful for that assistance and therefore accept the conditions, but a Board priority is to ensure that we do not need to rely on this funding in future, so that we can operate on a full salary cap for season 2019. We also need to recognise that despite the cap restrictions, our recruiting processes also have to improve and we are making this a priority.

Financially, members will know that we've come from a crisis

situation and made steady improvement over the past 3 years. Our results for 2016/17 show both a statutory and cash profit for the first time in many years. A lot of work and sacrifice has gone into this result and our task is to steadily continue this welcome trend.

Our football club is all about people. At every level of our club, there are people who care. Whether you're selling raffle tickets, cooking the barbecue, coaching juniors, looking after the property, raising funds through coterie groups, making sure the players have drinks, attending to injuries, looking after the mini-league, or supporting the club in any way, you are our club and we don't exist without you.

This has been a challenging year for our Board and I thank every member for their tireless work and passion for our club. Your decisions, over many years, have turned the club around and we can now dare to be optimistic on so many fronts. Thanks also to our CEO, David Grenvold, for his guidance and management and to all our staff for their commitment, their extra hours and their expertise.

To the Westonians, the best coterie group possible, thank you for your continuing, unwavering support and also to those retiring who have worked so hard for their club. John Pirakis (and Gillian), Tony Davidson, David Price, David Saint and others, your efforts have made such a difference over so many years. Thank you also to President Graeme Barton and Fay for your tireless work over so many years.

We are fortunate to have a group of supporters who have financially rescued this club and guaranteed its future – the Wolfpack. With our CEO, I met with the Wolfpack earlier in the year to ask for their further financial assistance. We were united in one thing: passion for our footy club; and more financial assistance than asked for was immediately forthcoming. Thank you, Wolfpack.



Planning for the future is vital and we have much to do. Some of our priorities are as follows:

For some time, we have supported women's football through the West Adelaide teams in the Adelaide Footy League and our own SANFL Women's team. We are well advanced in discussions with the Board of the Adelaide Footy League club to further that relationship and to provide a welcoming environment for all players and officials. This is an exciting opportunity for both entities.

Our Past Players' Association is vital in recognising and providing opportunities for those who have represented us on and off the field. Discussions are continuing to widen the reach of the Past Players' Association, with the club providing more resources and assistance.

As much as our history is important, we need to refresh and widen our reach. Our clubrooms and oval precinct need to be a home for more of our community, including our multi-cultural community, and we have instituted a program to further this as a vital part of our future. Our relationship with our council, the City of West Torrens, could not be better and we thank the Mayor, John Trainer, Councillor George Demetriou, City Manager Terry Buss and all the Council for their continuing support. With that support, an application for funding to upgrade the City Mazda Stadium area is in its initial stages and, if approved, it will have a very positive effect on what we can offer on game day to all patrons.

We are a family club. That is a key pillar of our existence. One of our major strategies is to provide a welcoming, stable environment for staff, members and all stakeholders at Westies and to recognise the value and work of all involved. We also share the loss of those who have served our club so well for so long and who are no longer with us.

As I have said, a football club is about people and each year we welcome new people and farewell others. Season 2018 saw retirements, as always, but we saw two of our favourite sons finish their playing careers. Their achievements will be discussed in more detail in other reports, but all at Westies thank Chris Schmidt and Daniel Caire for all they've given for our club. They leave the field knowing they are held in the highest regard by all Bloods fans, each in their own way.

After 16 years on the Board, including six years as President and 10 years as our League Director, Paul Sperling is retiring from official duties. Paul's contribution to our club has been massive and we acknowledge the huge positive contribution he has made to our club.

I thank and congratulate those who won our awards for senior, junior and women's football. They represent the best of skill and commitment to the club, shared and supported by all their teammates. They're supported by so many, but special thanks to Football Manager Andrew Marks, Talent Manager Jason Porplyzia and all the coaches and support staff.

This has been my first year as President and I thank previous President Richard Sykes and those who have served so well on the Board over the past several years. We are seeing the rewards of your hard work now and I also thank Vice-President Graeme Barton and our current Board for their support and guidance over the year.

Those who don't know us often find it hard to understand the West Adelaide Football Club. We're a relatively small SANFL club, we punch well above our weight in so many areas, but we hold together and succeed because of our passion, commitment and love for West Adelaide. When we look to thank our major sponsors, we know they're Adelaide Galvanising Industries and City Mazda and SCF, but we think of Tony & Lynn Grantham, Stuart and Pam Nunn, Phil and Wendy Grieg, Murray and Alexia Forbes and Richard and Jo Sykes. We think, without exception, West Adelaide people, as well as sponsors, and that extends throughout our sponsorship group. Thank you all.

There is so much to look forward to in coming years, but it will take a united, determined club to achieve it. And we will.

As with all our sponsors the club acknowledges your financial support which enables us to compete with the rest of the clubs, some of which have very strong financial positions.

We welcomed Rhianon Reese, Membership and Administrations Coordinator to the team and she has grasped the role with both hands and continues to make our membership campaign one of the best in the league as well as managing our website and databases in a professional manner. Bridget Aiston, Partnerships and Events Manager continues to drive the sponsorship, events and fundraising aspect of the business with great success and I thanks them both for their dedication to the club.

Our venue continues to evolve into a destination to eat, drink and play and it will be critical for the future of the club that we make this a place where everyone feels welcome. Trading in our bar and bistro improved significantly as did our functions revenue. The one area of concern was our gaming business. This part of the venue had a very tough first six months but recovered well in the back part of the year with the installation of some new gaming machines. There is a great deal of debate around the gaming industry in the state at the moment however we should remember that the WAFC is a non for profit entity returning proceeds to community sport. The venue staff have been fantastic in the way they have continually tried to make all the patrons and members feel welcome and I thank them for all their hard work throughout 2017. As we look forward to 2018 in this part of the business we will welcome a new Venue and Gaming Manager in February who will be responsible for making our venue a place we are all proud of and one that offers a great experience to all who visit it. Gayle Dolphin, Finance Manager has done a fantastic job ensuring our books are balanced every month and we certainly appreciate her astute management of our finances in a very challenging role.

SENIOR PROGRAM

After the disappointment of the 2016 season, both players and coaching staff were keen to turn our fortunes around in 2017. Many of their group went on to play U18 football and excel including Jason Westley, Tyson Kent, Beau Nunan, Zac Wooldridge, Riley Thilthorpe and Bailey Chamberlain.

I was lucky enough to coach the U15 Country side for the intrastate championships with the support of Jack Agostino. Naomi Maidment coached our metro group with the help of Chris Burgess and our U17s ran out under the guidance of Daniel Richardson. For the first time in seven years the opening day saw all three sides win on the same day. Some of our more promising players included Cooper Mackereth, Daniel King, Darren Virgo, Liam O'Connor-Dawkins and Cooper Anderson.

One of the great strengths of our Elite Development Program is the involvement of our senior players. Thomas Keough, Daniel Webb and myself managed the programs and we received great assistance from Jack Agostino, Murray Waite, Chris Burgess and Jonty Inglis. Many of our current senior players have experienced our current Elite Development Program and can all vouch for the importance and value in learning from those at the top SANFL level during those formative years. Our players are accredited level one and two coaches and this creates an amazing experience for these upcoming players, one that separates us from other SANFL clubs.

Again our U13 and U14 groups competed against Woodville-West Torrens on two occasions throughout the year with our boys winning in all four games. They all gave a great indication of the promising future of the club.

As always we visit our country zone regions during the bye weeks of the season to promote the football club, running school coaching clinics, club trainings and implementing our newly-developed 'Building Better Bloods' educational schools program. This is a great way for us to bring the football club to the doorstep of our country people and continue to build the strong ties that exist within our zone.

WOMEN'S FOOTBALL

The football club was lucky enough to be granted one of the licences in the inaugural SANFLW season in 2017. This was a just reward for the great pioneering work the club has been involved in over the last six years in the women's space. Our team was led by Brooke Copeland who received great support from Shane Moon. Unfortunately we were unable to capture a win during our six-game season, however the players battled courageously up until the final game.

Brooke was offered an expanded role with the Adelaide Football Club women's side following the close of the season and so has departed to pursue that opportunity. We thank her for her great work during the challenging start-up of our SANFLW team and wish her the best with her future coaching endeavours.

The girls' football program has continued to grow over the last few years and again this year a four-week season was held for U14 and U17 age groups. Our U14s, under the expert tutelage of Jack Agostino, breezed through their competition to take top honours whilst our U17s also showed great promise with Andrew Marks at the helm. Many of them will go on to represent us at SANFLW level in 2018.

We are fortunate to have an amazing number of people who go above and beyond to make sure our boys and girls run out on the weekend as well prepared as they can be to tackle the challenges of SANFL footy and keep them performing at their best. A special thank you to all of them. Our medical team headed up by Ange Moran and assisted by Brendon O'Leary are recognised by the players and within the SANFL as delivering one of the best rehabilitation and care programs in the league. Our statisticians and timekeepers do a terrific job anywhere, anytime and in any conditions. The property staff also should be noted for their hard work in keeping our players looking like the professional outfit they are as they take the field.

Another special mention goes to our team managers, Patrick O'Driscoll, Ted Kerley, Kate Matonia and Zoe Wecker for their great help and support. As well as being great people they go above and beyond and would certainly do more than most team managers.

The off-season has certainly been a busy one at West Adelaide as a period of change has occurred. It was amicably decided between the football club and Mark Mickan that his tenure would close at season's end. It gave us a chance to reflect on the tremendous contribution Mark has made to the football club as a player, administrator and coach. A four-time Best and Fairest winner during his playing days, perhaps he will be best remembered for bringing back the premiership cup to the club for the first time in 32 years as Senior Coach in 2015, masking the pain of missing through injury as a player in 1983. He has certainly left an indelible mark on the club and his presence will always be welcome.

Our strength and conditioning staff at both junior and senior level also moved on to bigger things. Sean Baker did an incredible job over his three years in charge at senior level and Josh Manual showed why Port Adelaide was keen to secure him on an internship with our juniors. We wish them the best in their fields.

The appointment of Gavin Colville as our new senior coach has been an exciting time throughout the football club. The rapport he has built with the playing group during his time as Reserves Coach is an asset and his ability to show empathy whilst also maintaining high standards and a level of expectation on the group has us well placed to return to the top in the future. Already he is leaving his mark on our playing group. We are all looking forward to achieving sustained success with Gavin taking the reins.

As we approach season 2018 it is also pertinent to farewell some club legends who retired at season's end. Daniel Caire, Chris Schmidt, Taite Silverlock and Brad Helbig were all members of our 2015 premiership side and have sadly hung up the boots. Daniel played for an incredible 12 seasons and over 200 games of SANFL league football as a one-club player developed through our junior system. He was also a Best and Fairest winner and will remain a true club stalwart. Chris captained our 2015 premiership, was a 100-game player and multiple Best and Fairest winner. His professionalism and leadership will be sorely missed. Taite displayed a high level of performance across more than 100 games as a player; more than anything though we will miss the highlights produced by the man dubbed 'the human helicopter'! Brad's time here was brief following his return from Richmond, however his impact was huge in that time, producing finals and Grand Final day performances of epic proportions.

2018 shapes to be an exciting and positive year and, rest assured, everyone within the football club is working hard to make sure it happens.

The Westies Wolfpack Pty Ltd is a unique & revolutionary WAFC friendly group of Investors that saved the club from Bankruptcy in 2015 by raising \$2 million dollars to prepay 10 years of Rent (upfront) to control the WAFC Building via a Head Lease Agreement. The Wolfpack subsequently entered a sub-lease arrangement with the Footballers Club to continue to use the building and pay rent @ 7.5% to the Wolfpack.

Since then the SANFL has commenced a 7 year (2016-22) Land Di-vestment Program (the sale of West Lakes, Football Park Land) from which the WAFC will receive \$2 million. This gives the WAFC the ability to regain control of its Building. The WAFC now already has \$350k share (33%) in the Wolfpack and will, endeavour to buyout the Wolfpack well ahead of its 10 year agreement.

The Directors of the Westies Wolfpack Pty Ltd are Richard Sykes, Dean Withers & Troy Abbott.

Investors are Richard & Jo Sykes, Troy Abbott, Murray & Alexia Forbes, Paul & Judy Sperling, Tony Davidson, Paul & Heather Evans, Robert & Yvonne Day, Graeme & Fay Barton, Dean & Sue Withers & now the WAFC.

This unique group of white knights are much envied and respected by all other SANFL Clubs. Don't be surprised if you see other club copying this innovative model.

We welcome the WAFC buying us out of our interest in the Club building as soon as it can. However, we are indenting to be around well into the future but acting in a different role, changing from Lease Holders to a Bank that the WAFC can come to for low cost lending for capital investments.

We have already commenced this ethos by lending \$100k to the WAFC to invest in the purchase of new Pokie Machines. We have also assisted in some short term lending to help with cash flow over the past 3 years.



Most recently, with a co-operative effort & support from our President, Lee Harradine & CEO, David Grenvold the Wolfpack we have been able to secure a much needed \$150k cash injection deal for the WAFC in the form of \$100k cash from the SANFL and \$50k rent relief from the Wolfpack. I applaud the continuous generosity the Wolfpack affords the WAFC it is warmly received and most appreciated by the WAFC Board & its members. This represents a reduction in their investment returns of 33% but significantly helps the WAFC.

We are about to welcome new Investors, Michael & Gayle Memmler, into the Wolfpack to on lend to the WAFC to commence an investment into a \$200k Solar Collection Infrastructure Project. We would like to extend an open invitation to anyone that would like to join us and become part of the Wolfpack movement.

- The Roger Luders League Leading Goal Kicker Award.
- The Grantley Fielke Award for the League Best Team Man.
- Guernsey name sponsor of Under 18s and Under 16s (2016/2017).

Other projects:

- Upgraded Westonians' room which included new ceiling, bar canopy, new lights, re-paint entire room and new Westonians' Honour Roll (20K).
- Funding to replace old scoreboard with electronic scoreboard over 2 years, at \$20,000 each year.
- Donated money to the mound bar upgrade project including cement floor polish, painting and building decking area.
- Installed reverse cycle air-conditioning for the players' change room, meeting room and property room under the grandstand. (10K)

- Completely refurbished the male and female toilets adjacent to the Sturt Pea Room at a cost of about \$30,000.
- Funded the replacement of the carpet in the ballroom. (Now Billiards.)
- Funded the establishment of a data base for the Past Players.
- Provided several thousand dollars for new computer equipment to analyse games and edit highlights for players and coaches.
- Upgraded two banks of downlights above the betting area in the bar of the club.
- Re-covered bar stools in main bar of WAFC.
- Installed heavy duty plugs in the Westonians' Room to ensure power for catering purposes.
- Purchase new gym equipment each year for the players' gym.
- Sponsored the Under 18 Honour Board in gymnasium.
- Donated \$1000 to the dancing troupe over numerous years.
- \$2000 donated to the "Grandstand Fire Appeal" re-build.
- Installed the trophy cabinet on the car park entrance to the club.
- \$1000 donation to assist establishment of History Group at WAFC.
- Donation to the WAFC Past Players and Officials' Dinner. (annually)
- Sponsored half the cost of the hot meat rolls for the players after each home game, with MGM Catering.
- Sponsor a bus for the Under 18 trips to the Riverland to play a combined Riverland team each year.
- In 2015 assisted 40 senior players in purchasing warm weather jackets which were embroidered with the Westonians logo to acknowledge the donation.
- Presented James Ezard with Magarey Medal framed jumper on his retirement.
- In 2016 funded the replacement of all lights in WAFC bar and administration area with power saving/ increased lux lights (6K).
- Funded coach-to-ground communication system, used by men's and women's teams.
- In 2017 funded GPS systems for football program (8K) and contributed \$2,000 towards preseason training apparel.

It is a pleasure to report to members on the financial statements for 2016/17. In my report last year, I stated that we were stable, had made great progress, but had one remaining major task: that of achieving a trading cash profit.

Our result for the year is a statutory profit of \$122,433.

Included in this figure is a 'trading cash profit' of \$57,330, the first such profit for many years, after a number of difficult years which produced significant losses.

This is a breakthrough result for our club and its importance can't be understated. My thanks go to our Board, who have worked tirelessly towards restoring our finances over many recent years, to our previous CEO, John Kantilaftas, whose knowledge and experience has been instrumental in achieving this result and to our current CEO, David Grenvold for his valuable work continuing that process. It is pleasing to report that we achieved our promised budgeted result this year and this is important for our financial credibility.

The statutory profit figure is affected by the following:

- Receipt of \$250,000 from the SANFL as the second payment of a total of \$2,000,000 from the West Lakes land divestment funds.
- A write-off of approximately \$30,000 in ATO interest charges from several years ago. We will be applying for a remission of these charges.
- A grant of \$64,000 from the SANFL to assist us with current debt reduction.
- Depreciation charges of \$185,000. Members should be aware that this always contains a charge of approximately \$67,500 depreciation on our buildings, as required by Accounting Standards. Clubs which do not own their own building do not have this charge.

In addition to the above, 2016/17 was the second full year of paying rent to the Westies Wolfpack Unit Trust (WWUT). The Wolfpack have been instrumental in assisting the club to return to a sound financial base and have now further agreed to significantly reduce the rent charged to the club for 2017/18, which will further assist our profitability. Due to this, the SANFL will also advance further funds to the club in the coming year.

We still face significant challenges to increase revenue. Our gaming operations continue to decline in the current economic climate (by 10% in 2016/17) and we are exploring ways to offer a better and more welcoming gaming experience. The change to our bistro operation has had an important positive effect on our results, with food sales up substantially and bar revenue increasing for the first time for many years, by 14%.

The \$250,000 Land Divestment funding through the SANFL has been accounted for in the financial statements, but was received soon after the financial year end. At that time, the club reduced debt by \$50,000 and purchased further units in the Wolfpack, bringing our holding to \$350,000 out of a total of \$1 million.

As long as we continue to make cash profits, we are on track to be totally debt-free by the time the SANFL Land Divestment Funds of \$2,000,000 are completed.

We have also taken the opportunity to reflect more properly the performance of the separate entities, the Football Club and Footballers' Club. As a result, some of the comparative figures in the financial statements must be read with this in mind, especially as they relate to administration expenses.

We need to be aware that although our statutory profit continues to increase our equity, the value of our gaming licences has decreased dramatically in recent years and this has had a very significant negative effect on that equity. The licences were shown with a value of \$1.45 million at 2014/15, but are now re-assessed each year to reflect accurately their real value as per the most recent trading round. This value is out of our control, so our task is to ensure continuing profitability.

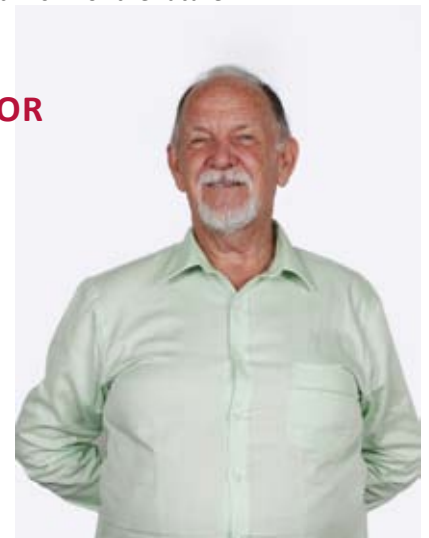
SO WHERE DO WE STAND NOW?

- We have a comfortable excess of assets over all liabilities, but the amount is dependent on the value of our land and buildings.
- Our only major non-current debt is to the WWUT, a group of Board Members and close supporters.
- Our current liabilities continue to reduce.
- We are confidently budgeting for an increased profit in 2017/18.

In short, we've gone from a dire, uncertain future 3 years ago, to now being relatively healthy and in charge of our own destiny. I would like to thank Adam May (SANFL Club Finance Officer) for his work on our accounting system and budgeting and Gayle Dolphin for her expert and helpful work with our day-to-day finances.

In football circles, there has been a cloud over our financial position for some time now. We still have a long way to go, but with stable and prudent financial decision making, the West Adelaide Football Club will be seen as financially strong. As members, you can be confident that our published results continue to reflect our optimism for the future.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (SA) 1985. The Board has determined that the association is not a reporting entity.

The financial report has been prepared in accordance with the requirements of the Associations Incorporation Act (SA) 1985 and the following Australian Accounting Standards:

AASB 1031 Materiality
AASB 110 Events after the Balance Sheet Date

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Accounting policies

The significant policies which have been adopted in the preparation of this financial report are:

(a) Income Tax

No income tax is payable as the Club is exempt from income tax by virtue of section 50 - 45 of the Income Tax Assessment Act 1997.

(b) Inventories

Inventories are valued at the lower of cost or net realisable value.

(c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(d) Property, Plant & Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment are measured on the cost basis.

The carrying amount of plant and equipment is reviewed annually by the Board to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets' employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

(c) Depreciation of property, plant and equipment

The depreciable amount of all fixed assets are depreciated on either a straight line or diminishing value basis over the useful lives of the assets to the Club commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

(f) Impairment of Assets

At each reporting date, the association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement or applicable Reserve.

(g) Employee Entitlements

Provision is made for the Club's liability for annual and long service leave arising from services rendered by employees to balance date.

Contributions are made by the Club to an employee superannuation fund and are charged as expenses when incurred.

(h) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(i) Interest-bearing loans and borrowings

All loans and borrowings are initially recognised at the fair value of the consideration received less directly attributable transaction costs. After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the effective interest method. Borrowings are classified as current liabilities unless the Club has an unconditional right to defer settlement of the liability for a least 12 months after the balance sheet date.

(j) Borrowing Costs

Borrowing costs are recognised as an expense when incurred.

(k) Comparatives

Comparative information has been reclassified to be consistent with the current year disclosure of equivalent information.

10 GOING CONCERN

West Adelaide Football Club Inc has a net current asset surplus at 31 October 2017 of \$42,575 (2016: \$192,037 deficiency). The Club recorded a loss for the year ended 31 October 2017 of \$273 (2016: profit of \$190,192. After adjusting comparative figures between entities, there was a profit of \$47,165).

The ability of the Club to continue as a going concern including the ability to pay its debts as when they fall due is dependent upon the continued support of its financiers, gate receipts, and other sources including the South Australian National Football League distributions and reducing operating costs.

Report on the Audit of the Financial Report

Opinion

We have audited the financial report of the West Adelaide Football Club Inc. (the Entity) which comprises the balance sheet as at 31 October 2017, the income statement, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement by members of the board.

In our opinion the accompanying financial report presents fairly, in all material respects, the financial position of the Entity as at 31 October 2017 and of its financial performance and cash flows for the year then ended in accordance with the *Associations Incorporation Act 1985 (SA)*.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. The Board has received a letter of support from West Adelaide Footballers Club Inc. indicating that it will provide financial support in order for West Adelaide Football Club to continue as a going concern and to be able to pay its debts as and when they fall due. This condition, along with other matters as set forth in Note 10, indicate an existence of a material uncertainty that may cast significant doubt about the Club's ability to continue as a going concern and therefore, the Club may be unable to realise its assets and discharge its liabilities in the normal course of business.

Board's Responsibility for the Financial Report

The board is responsible for the preparation of the financial report that gives a true and fair view, have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the *Associations Incorporation Act 1985 (SA)*, and is appropriate to meet the needs of members. The board's responsibility also includes such internal control as the board determines is necessary to enable the preparation of a financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the directors are responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless directors either intend to liquidate the entity or to cease operations, or have no realistic alternative but to do so. The board is responsible for overseeing the Entity's financial reporting process.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (SA) 1985. The board has determined that the Club is not a reporting entity.

The financial report has been prepared in accordance with the requirements of the Associations Incorporation Act (SA) 1985 and the following Australian Accounting Standards:

AASB 1031 Materiality
AASB 110 Events after the Balance Sheet Date

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income Tax

No income tax is payable as the Club is exempt from income tax by virtue of section 50 - 45 of the Income Tax Assessment Act 1997.

(b) Inventories

Inventories are valued at the lower of cost or net realisable value.

(c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(d) Intangible assets

Intangible assets represent gaming machine entitlements. These are reviewed for impairment annually and when gaming machine licences are sold the full value of the proceeds are reflected in income and the asset revaluation reserve is reduced to reflect the portion of the revaluation reserve applicable to the gaming machine licences sold.

(e) Property, Plant & Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment are measured at cost.

The carrying amount of plant and equipment is reviewed annually by the Club to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets' employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

(f) Depreciation of property, plant and equipment

The depreciable amount of all fixed assets are depreciated on either a straight line or diminishing value basis over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

(g) Impairment of Assets

At each reporting date, the Club reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(h) Employee Entitlements

Provision is made for the Club's liability for annual and long service leave arising from services rendered by employees to balance date.

Contributions are made by the Club to an employee superannuation fund and are charged as expenses when incurred.

(i) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(j) Interest-bearing loans and borrowings

All loans and borrowings are initially recognised at the fair value of the consideration received less directly attributable transaction costs. After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the effective interest method. Borrowings are classified as current liabilities unless the Association has an unconditional right to defer settlement of the liability for a least 12 months after the balance sheet date.

(k) Borrowing Costs

Borrowing costs are recognised as an expense when incurred.

(l) Comparatives

Comparative information has been reclassified to be consistent with the current year disclosure of equivalent information

8 GOING CONCERN

West Adelaide Footballers Club Inc has a net current asset deficiency at 31 October 2017 of \$286,999 (2016: \$233,253). The Club recorded a profit for the year ended 31 October 2017 of \$122,706 (2016: loss of \$142,867). After adjusting comparative figures, there was a profit of \$160.
