PRESIDENT'S REPORT

It is with a great feeling of pride and satisfaction I compile the 2019 Presidents report. The results the club achieved both on and off the field across the year were simply exceptional and a wonderful reward for the huge number of people that have worked tirelessly through times of extreme adversity without ever losing faith and belief that we could achieve the ultimate goal of winning the Premiership. On Grand Final day/ evening, to be able to witness the sheer excitement and joy on the faces of not just the players, but our extremely loyal and long suffering members and supporters was something I will never forget. The day made even more special by beating our arch-rival Port Adelaide.

Congratulations to Mark Stone and the playing group on what was a magnificent performance not only on Grand Final Day but across the year. As supporters we were confident that each week the team would give 100%, which is all we can ask for as a club. Paul Sandercock in his role as Football Manager has done an excellent job over recent years to formulate a squad of players with strong character and skills for Mark and the coaches to work with. It is exciting news that Mark has extended his contract with Glenelg for another 3 years, enabling the club to continue to build on this culture and hunger for sustained success.

Glenelg Football Club was awarded the Stanley H Lewis Cup for the most successful club across all grades in the SANFL. The under 16's won the Premiership and the under 18's and reserves played off in the Finals. This was a remarkable effort when you take into consideration how young our reserves team was throughout the year and especially in the finals, which in turn puts pressure on the under 18's. The GFCW team also played some great football and continued to develop and improve as the season progressed, making the SANFLW Finals. Congratulations to all the coaches and support teams working with these grades, your efforts were certainly outstanding.

I must acknowledge some exceptional individual performances in 2019 with Luke Partington winning the Magarey Medal, Liam McBean the Ken Farmer Medal for the leading goal kicker, Mathew Snook the Jack Oatey Medal for best afield on Grand Final Day and Jesse White being awarded the John H Ellers Award as the club's Best & Fairest player across the season.

It was simply an outstanding result by everyone involved in the football department and a massive thankyou to all of you, especially the volunteers for the countless hours you put in across the year to enable our teams to have the best chance of success. The financial result was also extremely positive, with the club achieving a \$447,050 consolidated net profit. This is the fourth year in a row that we have written a profit, which enables the club the opportunity to reinvest into our football resources and facilities for our members, supporters and local community.

It was also positive to see our debt reduce by \$320k in 2019. Whilst our debt position continues to improve, high debt levels continue to remain our biggest challenge and a major focus of the Board.

The excellent relationship we have with the council continued and we are working through these financial challenges with them. We thank Amanda Wilson (Mayor), Roberto Bria (CEO of COHFB) and the COHFB elected members for their continued support.

We have provided a financial executive summary in the annual report that succinctly details our current financial position for you, rather than me expanding on it here.

There have been some significant announcements recently in regards to leadership changes at the Glenelg Football Club for 2020. Glenn Elliott, who has been CEO of the club for the last 4 years, has retired to spend more time with his wife, Lois, and their family. Glenn has done an excellent job, after coming into Glenelg Football Club at an extremely vulnerable and difficult time. He must be congratulated on the leadership and direction he provided his team over his time at GFC. The Premiership and the current financial position are a testament to Glenn's efforts and he deserves considerable recognition for this transformation. On behalf of everyone at Glenelg Football Club, I would like to thank Glenn for his outstanding service and wish him, Lois and his family all the best for the future.

Nathan Godfrey has been appointed as CEO, starting in late January 2020. Nathan has an outstanding background, including experience working across multiple codes such as AFL, A-League, and Rugby Union.

Peter Carey also replaced me as President at our October board meeting. As most people were aware this was planned at the start of 2019, and it is a real coup for the club to have someone with Peter's credentials and passion for GFC to take on the Presidents role. I believe one of the most important roles of a President is to ensure there is a strong succession plan and I could not be more confident of Glenelg's future with Peter stepping into the position.

I have really enjoyed my time as President of the Glenelg Football Club and feel honoured to have be given the privilege to have this role for the last 5 years. I would like to thank everyone involved with the club for their support, even when at times I know the decisions that we made were not universally agreed on. To the Board in-particular that have worked extremely hard to drive success and a strong culture at the club, thank you for your support and commitment, it is much appreciated. To Glenn, Kristin Jeffrey, Paul Sandercock, Mark Stone, Emma Ross and Damien Owens, I have enjoyed working closely with you and appreciate your passion for the club and the hard work and genuine care you and your teams show to ensure we continue to improve on and off the field.

A list of acknowledgements is printed later in the report thanking everyone who has been involved last season, so I will not repeat that. However, to all our sponsors at every level, thank you for your continued association with the Glenelg Football Club, without your support we could not survive.

EXECUTIVE FINANCIAL SUMMARY

Glenelg Football Club Inc & Glenelg Footballers' Club Inc Financial Summary for the 31 October 2019 Financial Statements:

The Consolidated Statutory Net Profit for the year ended 31 October 2019 for the Glenelg Footballers' Club (Venue) and the Glenelg Football Club (Football) was \$447,050. The prime factors were that of an improved Licensed Club result and the benefits across both Clubs for winning the 2019 SANFL Premiership. It is clearly the best consolidated outcome in recent years.

Whilst the financial results show stability, we still need to maintain improvements in our financial results to assist us in reducing our debt and reinvesting back in the Clubs. We appreciate the ongoing support we have received from the City of Holdfast Bay. Our main source of income in Gaming Revenue has improved following re/branding and investment in new gaming machines and promotions. We acknowledge the social responsibilities around gaming, but respect that this is a major revenue line for the for many SANFL Clubs, with returns largely linked to each Club's geographical location. We continue to focus on our Bar and Kitchen sales, with both portfolios returning sound results. Both are areas of continuous improvement and daily delivery of both quality and variety meal offerings and customer service. Over the past two years we have developed a cost-efficient business model.

On the football side, the premiership led to improved results in most portfolios, including membership, merchandise and sponsorship. The pleasing thing is that our Sponsorship remains one of the highest in the SANFL, which credit needs to be given to the Commercial team. Our football expenses declined in 2019, but we continue to review our football department expenditure to ensure that we operate efficient yet highly competitive football operations.

Based on the original SANFL Land Divestment Distribution projected of \$2m, which we are still due to receive \$1,225,000 by October 2022, we are projecting our debt to the ANZ Bank to be \$227,666 and the City of Holdfast Bay to be \$1,029,589 at the end of October 2022. Based on financial outcomes we will not extinguish the balance of our debt of \$1,257,589 by October 2022 and therefore the Board are still looking for strategies to clear the balance of debt by the time we receive the final SANFL Land Divestment distribution in October 2022.

We look forward to a successful 2020 football year which would go a long way to sustaining our improved financial results.


Acknowledgements

Season 2019 saw the Tigers end a 33-year Premiership drought with a ruthless and entertaining style of football. Foundations for such a successful year were laid at the beginning of 2018 with the appointment of Mark Stone as Senior Coach. Winning the last 6 games of the 2018 season also indicated that the club had the game plan and players to return to finals football. As a result, there was an expectation in the air.

The additions of Cory Gregson (returning to the club from Geelong) and Luke Partington (returning to Adelaide after several years at West Coast) bolstered the midfield, while the return of Brad Agnew and Liam McBean from overseas adventures gave us more flexibility and experience. Michael Virgin joined us after a year away from SANFL football, while Rulla Kelly-Mansell joined us from Tasmania.

Luke Partington had an outstanding year. He won the Magarey Medal, The R.O. Shearman Medal (Coaches votes) and the SANFL Digital Pass Player of the Year. Liam McBean won the Ken Farmer Medal (SANFL Leading Goalkicker) and Matt Snook won the Jack Oatey Medal for Best on Ground in the Grand Final. We also had Chris Curran and Max Proud as members of SA State Team. Both players made great contributions as the side beat WA on their home turf.

Two players achieved the 100-game milestone for the club this year. Chris Curran and Matt Snook were rewarded for their consistency and commitment over many years. Marlon Motlop also played his 100th SANFL match, having played a number of games with West and North before joining Glenelg. The 100-game milestone at SANFL level is a great achievement in the current football climate.

The Club has again experienced a significant turnover of players since the end of season 2019. The challenge continues to find the balance between family, work and football. Several players have left this year looking for more opportunities.

The Club would like to thank the following players for their commitment to the Glenelg Football Club: Ben Sawford (South), Josh Koster (West), Sam Davis (North), Jesse White (retired), Seb Schreiber (Country), Brad Potter, Elliot Chalmers (North) and Josh Scott (Country). Chris Curran will be returning to the club in 2021 after undertaking a country placement with his medical studies.

Congratulations to Will Gould (Sydney) and Brad Close (Geelong) on their selection in the 2019 AFL National Draft. We look forward to watching them develop at the highest level and wish them all the very best as they embark on the next phase of their footy journey.

The GFCW Team showed significant improvement in season 2019. Jason Fairall (Coach) worked tirelessly in the off-season to recruit players who were committed and willing to work hard to improve. He introduced a game style that was well received by the players and this resulted in a much better onfield performance. Jason was well supported by Lexia Edwards, Tammy Scott and Ang Moritz in providing a program that saw many of the girls improve rapidly. The emergence of Caitlin Gould, Ellen Fauser and Sam Franson saw them have an influence on game day. The continued development of Madisyn Freeman and Tamsyn Morriss was pleasing to watch, and the performances of Lucy Bellinger, Cass Hartley and Ellie Kellock all contributed to the club playing finals football for the first time. A loss to North in the Elimination Final (Grand Finalists) by 2 points was a reflection of how much ground the girls had made up from the previous season.

Cass Hartley has decided to step down from the Captaincy in season 2020. I would personally like to thank Cass for her dedication to the role, her leadership, her support of the GFC and for her willingness to get involved and represent the club in such a professional manner. Cass has set a great example for others to follow and has been an enormous contributor to the GFCW program since its inception.

The club would like to thank Kieron Hicks for coaching the Under 18 team and working so diligently as our Talent Manager. Kieron has earnt the respect of all involved in the SANFL in his short time with the Club. He will continue to assist the GFC SE Academies as he returns home to Padthaway to be closer to family as he and partner Jess await the birth of their first child. I wish them both all the very best for the exciting times ahead. Kieron has been replaced by Darren Trevena. Darren brings with him a wealth of experience from a coaching and administration perspective.

Scott Uppington in his first year as Coach continued the recent success of our Under 16 team. Scott worked hard at providing the players with a well-rounded program. He had the boys playing exciting football by seasons end and victory was well deserved.

Paul Sherwood decided to end his role as Senior Assistant Coach at the end of the season. We are disappointed to lose such a valued clubman and Coach. Paul developed strong relationships with the players in his short stay back at Glenelg. He returns to Westminster OS as their Senior Coach for 2020.

Season 2020 will see Clinton Alleway, Jack Horan and Adam Hartlett join the Senior Coaching panel. They have all had successful SANFL careers and have coached their own sides in recent years. Their addition to the coaching staff will not only offer a great deal of support to Mark but also the playing group as they draw on their experiences.

Season 2020 is upon us and with that we face a different challenge. We are now the competition pacesetter in a very even competition. All clubs strive to improve in the off-season, and we are no different. While we have seen the loss of several key players, the club has recruited well to fill the void. Matt Allen and Billy Stretch have returned to the club after several years in the AFL. Jack Hannath joins us from NT Thunder and Curtis McCarthy and Jackson Edwards have also returned to the club after stints in Victoria. The development of some of our younger players such as Reid Kuller, Jordan Moore and Callum Park will be exciting to watch, as will the continued improvement of Brady Searle, Seb Kerrish, Darcy LeCornu and Finn Betterman.

- We have welcomed the ACH Group as a tenant and partner. Their fit out is spectacular and is evidence of their commitment for the long term
- Glenelg now has first class changerooms and gymnasium facilities. Council has invested in creating a new facility at the Sparks Grandstand site
- Members and Sponsors were thanked for their continued support of the Club and acknowledged the relationship with Gliderol
