

Terms and Conditions – the Bays Lotto fundraiser

These terms and conditions ("Terms") constitute a legally binding agreement between you ("Participant") and the Glenelg Football Club (GFC) regarding your participation in the Bays Lotto fundraiser ("Bays Lotto").

By entering the Bays Lotto, you acknowledge and agree to comply with these Terms.

1) Prize Draw:

- a) The Bays Lotto consists of 52 weekly draws throughout the whole year.
- b) A cash prize of \$250 (or a minimum of 20% of the prize pool) will be awarded to the winner of each weekly draw.
- c) The first draw will be held on Thursday 27th March 2025.
- d) GFC reserves the right to cancel or abandon the Bays Lotto if there are insufficient entries or if it becomes economically unfeasible for the Club.
- e) In the event of discontinuation, any outstanding funds will be disbursed accordingly.
- f) The name listed on your registration will be used as your entry and an email will be sent to confirm that your registration is accepted.

2) Draw Process:

- a) The winner will be drawn by a random number generator at approx. 5pm every Thursday at the Glenelg Football Club, Brighton Rd, Glenelg SA 5045 and posted on the Glenelg Football Club Facebook page.
- b) GFC will conduct the draws at its sole discretion.
- c) The winner of each weekly draw will be publicly announced on the GFC social media platforms.
- d) The winner of each weekly draw will be personally notified by GFC.
- e) Prize money will be disbursed by COB each Monday following the draw, either through direct deposit or an alternate agreed arrangement.

3) Payment options:

- a) Participants can make payments through the following options:
 - a. An annual payment of \$520 upon joining from the commencement of a participates confirmed entry, noting participates can enter at any time of the year.
 - b. Paying \$10 each week either by:
 - i. In cash directly to GFC Reception by 4pm Wednesday, for the follow day's draw.
 - ii. A weekly payment of \$10 through direct debit deduction from a nominated debit or credit card. (Note: Participants can withdraw their entry at any time, see Clause 5).
- b) Entry tickets must be paid and confirmed by 11:59pm each Wednesday to be eligible for the forthcoming Thursday draw.
- c) Following payment, a participants entry confirmation will be forwarded via email or text, confirming purchase.



4) Restrictions:

- There are no restrictions of individuals or roles within the GFC to enter.
- Persons under 18 years of age, are not permitted to enter.
- There are no restrictions on the number of people who register to enter.

5) Forfeiture of Prize Money:

- a) Participants who choose the weekly payment option through the direct debit system must maintain their enrolment in the system for the entire duration of their participation in the Bays Lotto.
- b) If a participant voluntarily removes themselves from the direct debit system they will forfeit any entitlement to receive the prize money from the very next draw for which they have paid up to as fourteen (14) days' notice is required to withdraw from the Bays Lotto (see clause e).
- c) If a participant, who has paid the upfront annual payment, voluntarily removes themselves from the Bays Lotto before the completion of the 52-week period, they will be refunded their entry fee for future remaining draws.
- d) Any participants who wish to withdraw from the weekly Lottery must provide fourteen (14) days written notice to Glenelg Football Club.
- e) GFC reserves the right to recover any prize money already disbursed to a participant who has violated this condition see clause (see clause b).

6) Commitment:

- a) GFC will administer the Bays Lotto in good faith and in the best interests of GFC.
- b) Neither organisation, nor any director, employee, staff member, officer, volunteer or representative of GFC shall be liable at any time for any errors, system malfunctions or decisions made in connection with the administration of Bay Lotto.
